THESE TESTS WILL BE HELD ON MOWED GRASS AND UTILIZE A BATTERY POWERED CONTINIOUS LOOP LURE MACHINE. THE BACK UP LURE MACHINE IS A DRAG LURE. SNOW FENCING WILL BE AROUND THE RUNNING AREA. The lure will consist of plastic contrasting in color with the immediate field environment. Electronic timing devices will be used, however hand-held stopwatches will be used in the event of timing device malfunction.

Running order:

First come, first serve. You must check in prior to the last dog in the test. The paddock master will take your run card and get you on the list after your dog is inspected. Events will be held concurrently.

INSPECTION: 8:30 AM EVENT STARTS: 9:00 AM

LUNCH BREAK: We will have a designated lunch break at the discretion of the trial committee, and it will be posted at the trial secretary's desk. No food or drinks available on site.

ELIGIBILITY and Conditions for FastCAT's

FastCATs are open to all dogs at least 12 months of age that are: Individually registered with the AKC

Recorded in the Foundation Stock Service (FSS) program Individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration Dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration. Dogs with breed disqualifications are eligible to enter.

Females in season may not enter--BITCHES IN SEASON AND LAME HOUNDS WILL BE EXCUSED and entry fees shall be refunded

A dog may enter only once per event. (An event is defined by an event number)

A fee of \$25.00 will be assessed for any returned checks

You are responsible to have your dog's health records up to date. The Club and/or Test Secretary assume no responsibility for incorrect or incomplete information given on the entry form. The Club and/or the Test Secretary assume no responsibility for injury, or a dogs' failure to recall.

Any person, upon reasonable complaint, may be asked to leave the grounds by the field committee. Children must always be under the control of their parents or guardian.

FastCAT ROLL CALL & INSPECTION

Roll call will be continuous. Competitors will check in at the check in table upon arrival at the test starting at 8:30 A.M. and continuing until running is complete. You can run both day's tests in the morning with at least 30 minutes in between. Each entry will be inspected for lameness, fitness to compete, and females in season as well as measuring for determining the handicap. If in the opinion of the inspection committee, any entry found to be lame, unfit to safely compete, or a female in season, that dog shall not be allowed to enter and entry fees shall be refunded. There may be a short briefing with instructions and announcements before we begin. We will be moving things along as efficiently as possible to avoid a backup and long wait times. FastCat will be running concurrently with an agility trial.

Introducing the FastCAT

The FastCAT /Test is a timed 100-yard dash for dogs. It is meant to be a fun and healthy activity of interest to any dog owner. FastCAT is a timed straight race of 100 yards and dogs run singularly. The dog's time to complete the 100-yard dash is converted into MPHs.

HOW IT WORKS

A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:

18" or greater = handicap is 1.012" up to less than 18" = handicap is 1.5Below 12" = handicap is 2.0

Points and TITLES

Points = MPH multiplied by the dog's handicap. FastCAT titles suffix titles are earned at designated milestones:

BCAT = 150 points DCAT = 500 points

FCAT = 1,000 points

FCAT# = every additional 500 points

Dogs will start up 10 feet behind the starting line. Prior to moving the lure to position it for the start, the lure operator shall announce "hold your dogs" to caution owners.

Timing

The time to complete the 100-yard dash is recorded to the nearest 1/100th of a second (e.g. 9.11). UITC will use electronic timing equipment. We will be using hand held timers in the event the electric timing equipment malfunctions.

Awards

-A light blue colored Ribbon will be awarded for each qualifying run -New title rosettes will be available

ADDITIONAL NOTES

- Anybody exhibiting unsportsmanlike behavior will be excused from the field and may be subject to further disciplinary action.

-Control of dogs is strictly enforced, on leash at all times except when running.

-Clean up and dispose of all trash including all dog feces. Remove the trash or put in receptacle provided at site.

-This event will be held at the same time as an AKC agility trial. Indoor crating is available. Please plan on covering crates or taking other necessary steps to keep dogs calm and quiet in the building while crating so as not to disrupt the agility trial. Disruptive dogs (barking or loud) may be asked to crate outside. No dogs are allowed in the restrooms onsite at any time.

-All dogs <u>MUST</u> be on a short leash and under control while on the test grounds except while testing. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Single piece slip collars/leads are allowed. Harnesses, with the exception of head halter types, are allowed. Flexi-leads are NOT PERMITTED on the grounds. There is NO SMOKING on the grounds. Pet waste containers are available outside the building. Please pick up after your dog. \$5 fine for loose dogs that cause interference with the test. All dogs must be on leash when not testing.

Crating: Only outdoor crating is available. Restrooms are in the agility building, masks must be worn at all times in the building.

Please write your dog's height at the withers next to the breed name on the entry form. If you do not do this YOUR DOG WILL BE ENTERED AS AN 18" HEIGHT if I do not already have your dog's height on file from a previous event.

DAY OF SHOW:

Each test allows 100 dogs. If the event fills a wait list will be maintained and individuals notified if their entry can be accepted. If the test does not fill or waitlist entries are not available to fill running slots, then gate entries will be allowed to reach our limit of 100 dogs. Gate entries close at the secretary's desk at 7:45 am. Cost for day of show entries is \$25.00! Make Checks payable to Go Dogs

I-80W via Exit 446 toward Lincoln. Follow directions above from East or West on I-80.

From the South on I-29: Keep left to take I-80 W towards Omaha. Follow directions above from East or West on I-80
